About the Workshop

The First Uttar Pradesh Deaf Workshop, organized by the All Uttar Pradesh Association of the Deaf (affiliated to the All India Federation of the Deaf, New Delhi), was held on 22nd June 2025 in Lucknow, with participation from over 42 districts.

The aim was to strengthen district-level Deaf leadership, promote awareness of the RPwD Act, 2016, and build inclusive networks across Uttar Pradesh. Discussions included sign language rights, accessibility, government schemes, and the role of local Deaf associations.
